Introduction

These OIDs are issued by HL7 New Zealand as the registration authority for New Zealand for OIDs derived from the HL7 International trunk. The HL7NZ root is 2.16.840.1.113883.2.18 Requests for New Zealand OIDs from this root can be directed to admin@hl7.org.nz

This document is broken into three sections. The sections are for CDA template ids, NZ specific code systems and NZ specific value sets.

The code systems are vocabularies that are defined in various supporting specifications and may be maintained by other bodies. When a specified sub set of codes is used from a code system then this set of codes is known as a value set.
